

Central Bank Survey: End-January 2017

The monetary base rose by Rs1,012 million, from Rs82,062 million as at end-December 2016 to Rs83,074 million as at end-January 2017, or by 1.2 per cent compared to an increase of 9.3 per cent registered between end-November 2016 and end-December 2016. The expansion in the monetary base reflected mostly the increase in liabilities to other depository corporations, more than offsetting the fall in currency in circulation and liabilities to other sectors. In January 2017, the annual growth rate of monetary base remained unchanged at 11.5 per cent as in previous month.

On the sources side of the monetary base, the net foreign assets of the Bank contracted by Rs3,274 million or 1.8 per cent, from Rs177,669 million as at end-December 2016 to Rs174,395 million as at end-January 2017. Net Claims on Central Government went up by Rs5,982 million, from negative Rs38,387 million as at end-December 2016 to negative Rs32,405 million as at end-January 2017.
