Coordinated Direct Investment Survey (CDIS): Results for Mauritius (End-December 2019)

Following the conduct of the Coordinated Direct Investment Survey (CDIS), the IMF released aggregated direct investment position data at the global level as well as that for all participating countries, including those for Mauritius as at end-2019. The CDIS is a worldwide survey of bilateral direct investment position, designed to improve the availability and quality of data on direct investment, both overall and by immediate counterpart economy.

Mauritius' CDIS position data

The stock of direct investment liabilities of Mauritius stood at USD323 billion as at end-December 2019, up from USD320 billion as at end-December 2018. The United States remained the preferred destination in terms of source direct investor in Mauritius with outstanding claims of USD56 billion as at end-December 2019, followed by Cayman Islands (USD46 billion), India (USD25 billion) and Singapore (USD25 billion).

The stock of direct investment assets of Mauritius amounted to USD273 billion as at end-December 2019, up by USD11 billion, from USD262 billion as at end-December 2018. India ranked first in terms of Mauritius' direct investments abroad with outstanding assets of USD121 billion as at end-December 2019, followed by Singapore (USD22 billion) and United Kingdom (USD20 billion).
