Coordinated Direct Investment Survey (CDIS): Results for Mauritius End-December 2024

The Coordinated Direct Investment Survey (CDIS) is a worldwide survey of bilateral direct investment position conducted by the IMF annually and designed to improve the availability and quality of data on direct investment. Following the conduct of the CDIS for end-December 2024, the IMF released aggregated direct investment position data at the global level and for all participating countries, including Mauritius.

Direct Investment Assets and Liabilities of Mauritius

The stock of direct investment liabilities of Mauritius stood at USD333.2 billion as at end-December 2024, down from USD337.9 billion as at end-December 2023. The United States remained the top source country of direct investment in Mauritius, with outstanding claims of USD58.7 billion, followed by India (USD47.5 billion), Singapore (USD30.7 billion) and Cayman Islands (USD28.9 billion).

The stock of direct investment assets of Mauritius amounted to USD348.1 billion as at end-December 2024, up from USD324.8 billion as at end-December 2023. India was the first destination country for direct investment abroad, with outstanding assets of USD173.8 billion, followed by Singapore (USD23.2 billion) and United Kingdom (USD17.4 billion).
