Gross Direct Investment Flows¹: 2017H1 and FY2016-17

1. Gross direct investment flows in Mauritius have been estimated at Rs9,724 million in 2017H1, higher compared to Rs7,960 million in 2016H1 (Table 1a). More than half of the inflows were directed to the 'Real estate activities' sector (Rs5,327 million), of which investments under the IRS/RES/IHS/PDS² amounted to Rs3,316 million. The 'Financial and insurance activities' and 'Construction' sectors received Rs3,123 million and Rs507 million, respectively, in 2017H1. Nearly a third of the direct investment inflows originated from Luxembourg (Rs3,254 million), while those from France and South Africa amounted to Rs2,479 million and Rs1,079 million, respectively (Table 1b).

On a fiscal year basis, gross direct investment flows in Mauritius have been estimated at Rs15,413 million during 2016-17, higher than the Rs12,878 million recorded during 2015-16 (Table 1c). More than two-third of the inflows were directed to the 'Real estate activities' sector (Rs10,300 million), of which investments under the IRS/RES/IHS/PDS amounted to Rs7,098 million. The 'Financial and insurance activities' and 'Construction' sectors received Rs3,255 million and Rs931 million, respectively, during 2016-17. Nearly 30 per cent of the direct investment inflows originated from France (Rs4,687 million), while those from South Africa and China amounted to Rs2,044 million and Rs1,118 million, respectively (Table 1d).

2. Gross direct investment flows abroad totalled Rs1,214 million in 2017H1 (Table 2a) and they were directed mostly to the 'Financial and insurance activities' sector (Rs722 million) and the 'Real estate activities' sector (Rs266 million). Direct investment flows to Kenya stood at Rs708 million while those to France amounted to Rs154 million (Table 2b).

On a fiscal year basis, gross direct investment flows abroad totalled Rs1,835 million in 2016-17 (Table 2c) and they were mostly directed to the *'Financial and insurance activities'* sector (Rs744 million) and the *'Real estate activities'* sector (Rs625 million). Direct investment flows to Kenya stood at Rs708 million while those to France amounted to Rs296 million (Table 2d).
