Preliminary Gross Direct Investment Flows: 2023 (Excluding Global Business Sector)

1. Gross direct investment flows in Mauritius have been estimated at Rs37,011 million for 2023 compared to Rs33,491 million in 2022 (Table 1a). The 'Real estate activities' sector was the major recipient of gross direct investment inflows, which was mostly received under *IRS/RES/IHS/PDS/SCS*¹, followed by the 'Agriculture, forestry and fishing' and 'Accommodation and food service activities' sectors. Gross direct investments in Mauritius were mainly sourced from France, United States and South Africa (Table 1b).

2. Gross direct investment flows abroad have been estimated at Rs1,216 million in 2023 compared to Rs8,920 million in 2022. These direct investment outflows were mainly directed to the 'Real estate activities', 'financial and insurance activities' and 'Manufacturing' sectors (Table 2a). The main investment destination were Kenya, United Arab Emirates followed by France.
