



Mauritius' International Investment Position¹ (IIP) End-December 2019 (Preliminary estimates)

1. Preliminary estimates of the International Investment Position (IIP) for Mauritius indicate a net foreign asset position of Rs962 billion (equivalent to USD26 billion) as at end-December 2019. Claims on non-residents have been estimated at Rs17,304 billion (equivalent to USD473 billion) while liabilities to non-residents have been estimated at Rs16,342 billion (equivalent to USD447 billion).
2. The net foreign asset position of the non-GBLH sector stood at Rs427 billion (equivalent to USD12 billion) as at end-December 2019. Non-GBLH residents' claims on non-residents amounted to Rs1,111 billion (equivalent to USD30 billion) while their liabilities to non-residents totalled Rs684 billion (equivalent to USD19 billion). Gross official international reserves of the country increased by Rs52 billion to Rs269 billion (equivalent to USD7 billion) as at end-December 2019 compared to end-December 2018.
3. The net foreign asset position of the GBLH sector has been estimated at Rs536 billion (equivalent to USD15 billion) as at end-December 2019. GBLHs' claims on non-residents are estimated at Rs16,194 billion (equivalent to USD442 billion) while their liabilities to non-residents are estimated at Rs15,658 billion (equivalent to USD428 billion).

Table 1 summarises the foreign asset and liability position of Mauritius by functional category as at end-December 2019.
