

Monetary Developments: April 2016

The annual rate of growth of Broad Money Liabilities (BML) gained some momentum in **April 2016.** BML grew by 9.0 per cent year-on-year in April 2016, up from 7.7 per cent in March 2016 and recorded increases in all of its components. Between end-March 2016 and end-April 2016, BML rose by Rs4,462 million, or by 1.0 per cent to Rs446,912 million, reflecting an increase of 1.1 per cent in narrow money liabilities and 1.0 per cent in quasi money liabilities.

Net foreign assets of depository corporations contracted again in April 2016. The annual growth rate of net foreign assets of depository corporations contracted by 7.4 per cent in April 2016, lower than the contraction of 9.0 per cent in March 2016. Between end-March 2016 and end-April 2016, net foreign assets rose by Rs17,799 million or by 3.5 per cent to Rs525,295 million.

Claims on other sectors by depository corporations grew at a higher pace during the period under review. The annual growth rate of claims on other sectors increased from 3.4 per cent in March 2016 to 5.1 per cent in April 2016. However, between end-March 2016 and end-April 2016, claims on other sectors fell by Rs3,902 million, from Rs435,001 million to Rs431,099 million. Net claims on central government rose by Rs1,369 million or by 2.9 per cent, from Rs47,472 million at the end of March 2016 to Rs48,841 million at the end of April 2016.
