

## **Monetary Developments: April 2017**

The year-on-year growth rate of Broad Money Liabilities (BML) dropped to 8.8 per cent in April 2017, from 9.6 per cent in March 2017. With the exception of time deposits, the remaining components of BML continued to expand. Between end-March 2017 and end-April 2017, BML rose by Rs1.4 billion, or by 0.3 per cent to Rs486.4 billion, led to a large extent by the increase in foreign currency deposits.

The year-on-year growth rate of net foreign assets of depository corporations decelerated in April 2017. The annual growth of net foreign assets of depository corporations declined to 5.0 per cent in April 2017, from 11.4 per cent in March 2017. Between end-March 2017 and end-April 2017, net foreign assets of depository corporations contracted by Rs13.9 billion or by 2.5 per cent to Rs551.5 billion.

**Claims on other sectors registered higher growth in April 2017 compared to March 2017.** Year-on-year, claims on other sectors grew by 8.3 per cent in April 2017 compared to an increase of 7.3 per cent in March 2017. Between end-March 2017 and end-April 2017, claims on other sectors rose by Rs0.4 billion, or by 0.1 per cent to Rs467.0 billion. Net claims on central government went up by Rs1.2 billion or by 2.0 per cent to Rs59.6 billion at the end of April 2017.
