

Monetary Developments: May 2016

The annual rate of growth of Broad Money Liabilities (BML) remained solid in May 2016. BML grew by 9.2 per cent year-on-year in May 2016, up from 9.0 per cent in April 2016 and recorded increases in all of its components. Between end-April 2016 and end-May 2016, BML rose by Rs2,737 million, or by 0.6 per cent to Rs449,649 million, reflecting an increase of 0.7 per cent in narrow money liabilities and 0.6 per cent in quasi money liabilities.

The annual growth of the net foreign assets of depository corporations remained in negative territory in May 2016. The annual growth rate of net foreign assets of depository corporations contracted by 2.9 per cent in May 2016, lower than the contraction of 7.4 per cent recorded in April 2016. Between end-April 2016 and end-May 2016, net foreign assets fell by Rs7,273 million or by 1.4 per cent to Rs518,022 million.

Claims on other sectors by depository corporations gathered additional momentum during the period under review. The annual growth rate of claims on other sectors increased from 5.1 per cent in April 2016 to 6.2 per cent in May 2016. Between end-April 2016 and end-May 2016, claims on other sectors rose by Rs4,240 million, from Rs431,099 million to Rs435,339 million. Net claims on central government rose by Rs98 million or by 0.2 per cent, from Rs48,841 million at the end of April 2016 to Rs48,939 million at the end of May 2016.
