



Monetary Developments: April 2022

Broad Money Liabilities (BML) contracted by 0.1 per cent in April 2022 compared to the preceding month. The annual growth rate of BML fell from 9.1 per cent in March 2022 to 1.5 per cent in April 2022.

Net foreign assets (NFA) of depository corporations went up by 0.6 per cent, from Rs869.1 billion in March 2022 to Rs874.2 billion in April 2022. Y-o-y, growth in NFA rose from 2.9 per cent in March 2022 to 12.4 per cent in April 2022.

Claims on other sectors (excluding financial derivatives) dropped by 0.6 per cent to Rs607.6 billion in April 2022, representing an annual growth of 6.0 per cent compared to 15.4 per cent in March 2022. Net claims on central government stood at Rs119.5 billion in April 2022.
