

## **Monetary Developments: December 2021**

Broad Money Liabilities (BML) contracted by 2.8 per cent as at end-December 2021 compared to end-November 2021. Year-on-year, growth in BML slowed from 13.5 per cent in November 2021 to 8.8 per cent in December 2021.

Over the month, net foreign assets (NFA) of depository corporations went up by 4.6 per cent to Rs894.2 billion. The annual growth of NFA rose from 14.6 per cent in November 2021 to 18.6 per cent in December 2021.

Claims on other sectors (excluding financial derivatives) contracted by 1.6 per cent to Rs601.8 billion in December 2021, representing an annual growth of 12.9 per cent compared to 15.0 per cent in November 2021. Net claims on central government contracted by 16.9 per cent to Rs106.4 billion in December 2021.
