

## **Monetary Developments: February 2020**

Broad Money Liabilities (BML) rose by Rs8.7 billion or 1.4 per cent, from Rs604.3 billion as at end-January 2020 to Rs613.0 billion as at end-February 2020. Year-on-year (y-o-y), BML grew by 9.5 per cent in February 2020, up from 8.9 per cent in January 2020. The y-o-y growth of BML in February 2020 was backed by increases in all of its components.

Over the month, net foreign assets (NFA) of depository corporations rose by Rs6.3 billion or 1.0 per cent to Rs663.3 billion. Y-o-y, NFA grew by 8.3 per cent in February 2020, lower compared to the growth of 18.2 per cent registered in January 2020.

Claims on other sectors (excluding financial derivatives) decreased by Rs4.2 billion to Rs492.2 billion. Y-o-y, claims on other sectors (excluding financial derivatives) went up by 6.0 per cent in February 2020 compared to an increase of 8.2 per cent in January 2020. Net claims on central government increased by Rs6.0 billion, or by 7.4 per cent to Rs86.6 billion in February 2020.
