

Monetary Developments: May 2019

Over the month, Broad Money Liabilities (BML) fell by Rs0.9 billion or 0.2 per cent to Rs564.4 billion, reflecting the decrease in deposit liabilities and debt securities, which more than offset the increase in currency with public. Year-on-year, BML grew by 6.0 per cent in May 2019, unchanged from the previous month. All the components of BML contributed to its increase on a year-on-year (y-o-y) basis.

Between end-April 2019 and end-May 2019, net foreign assets (NFA) of depository corporations went down by Rs14.5 billion or 2.4 per cent to Rs587.3 billion. The y-o-y growth rate of NFA contracted by 2.4 per cent in May 2019, as against an expansion of 5.1 per cent in April 2019.

Over the month, claims on other sectors (excluding financial derivatives) increased by Rs2.7 billion to Rs471.7 billion. Y-o-y, claims on other sectors (excluding financial derivatives) rose from 5.4 per cent in April 2019 to 7.4 per cent in May 2019. Net claims on central government increased by Rs2.3 billion, or by 2.8 per cent to Rs83.8 billion in May 2019.
