

Monetary Developments: November 2018

Broad Money Liabilities (BML) grew by 7.5 per cent, year-on-year, in November 2018, compared to 7.0 per cent in October 2018. All the components of BML contributed to its increase over the year. Between end-October 2018 and end-November 2018, BML rose by Rs2.4 billion or 0.4 per cent, mostly backed by the increase in rupee deposits.

The annual growth rate of net foreign assets (NFA) of depository corporations dropped to 1.5 per cent in November 2018, from 12.7 per cent in October 2018. Over the month, NFA went down by Rs25.2 billion or 4.2 per cent.

Year-on-year, claims on other sectors (excluding financial derivatives) remained unchanged at 3.8 per cent in November 2018, compared to the previous month. Between end-October 2018 and end-November 2018, claims on other sectors (excluding financial derivatives) rose by Rs0.7 billion to Rs454.9 billion. Net claims on central government increased by Rs3.2 billion, or by 4.3 per cent to Rs76.7 billion in November 2018.
