

## **Monetary Developments: September 2019**

Over the month, Broad Money Liabilities (BML) rose by Rs2.9 billion or 0.5 per cent to Rs576.8 billion, mostly on account of the increase in foreign currency deposits. Year-on-year, BML grew by 7.4 per cent in September 2019, up from 7.1 per cent in August 2019. All the components of BML contributed to its year-on-year (y-o-y) growth in September 2019.

Between end-August 2019 and end-September 2019, net foreign assets (NFA) of depository corporations went up by Rs10.3 billion or 1.7 per cent to Rs614.8 billion. Consequently, the yo-y growth rate of NFA rose to 7.6 per cent in September 2019, higher compared to a growth of 0.9 per cent in August 2019.

Over the month, claims on other sectors (excluding financial derivatives) increased by Rs4.2 billion to Rs486.2 billion. Y-o-y, claims on other sectors (excluding financial derivatives) remained unchanged at 7.1 per cent in September 2019, compared to the previous month. Net claims on central government decreased by Rs1.4 billion, or by 1.7 per cent to Rs81.7 billion in September 2019.
