

Intervention on the Domestic Foreign Exchange Market

Today the Bank intervened on the domestic foreign exchange market and purchased USD10.5 million and EUR600,000 at weighted average rates of Rs30.3286/USD and Rs39.5583/EUR respectively, for same day settlement.
