

Intervention on the Domestic Foreign Exchange Market

Over the week 4 to 8 October 2010, the Bank intervened on the domestic foreign exchange market on one occasion.

On 8 October 2010, the Bank purchased an amount of USD9.3 million at the weighted rate of Rs/USD29.8956.
