## Communiqué NOTICE OF TENDER FOR GOVERNMENT OF MAURITIUS TREASURY BILLS

Primary Dealers may submit bids through the Reuters Dealing System or on tender forms which are obtainable at the seat of the Bank or on its website at https://www.bom.mu Completed tender form/s should be placed in a sealed envelope, marked "Tender for 364-Day Government of Mauritius Treasury Bills" and should be deposited in the tender box, marked A, for Government Securities, at the Banking Hall of the Bank of Mauritius, Bank of Mauritius Tower, Sir William Newton Street, Port Louis, before $\mathbf{1 0 . 0 0}$ a.m. on Friday 14 August 2015.
4. Results of the auction will be announced on the same day and successful bidders will be required to effect payment of the cost price of the GMTB through the Mauritius Automated Clearing and Settlement System, at latest by 1.00 p.m. on the same day, i.e., on Friday 14 August 2015.
5. The Bank reserves the right to accept or reject any bid either in full or in part, without assigning any reason in respect thereof.
