

Central Bank Survey: April 2014

The monetary base went down by Rs413 million or 0.7 per cent, from Rs62,483 million at end-March 2014 to Rs62,070 million at end-April 2014 as compared to a decrease of 2.5 per cent registered between end-February 2014 and end-March 2014. The decline in the monetary base reflected mainly a decrease in Liabilities to Other Depository Corporations (reserve deposits).

The annual growth rate of monetary base was 27.2 per cent in April 2014 compared with 20.2 per cent in March 2014.

On the sources side of the monetary base, net foreign assets of the Bank of Mauritius grew by Rs4,378 million or 4.0 per cent, from Rs110,343 million at end-March 2014 to Rs114,721 million at end-April 2014. Net Claims on Central Government went down by Rs4,509 million, from negative Rs13,388 million at end-March 2014 to negative Rs17,897 million at end-April 2014, mainly as a result of an increase in liabilities to Central Government. Claims on Other Depository Corporations went down by Rs76 million, from Rs3,529 million at end-March 2014 to Rs3,454 million at end-April 2014, as against a rise of Rs70 million in the previous month.
