

## Central Bank Survey: December 2013

The monetary base went up by Rs8,593 million or 16.0 per cent, from Rs53,757 million at end-November 2013 to Rs62,350 million at end-December 2013 as compared to a rise of 3.4 per cent registered between end-October 2013 and end-November 2013. The growth in monetary base reflected mainly increases in Currency in Circulation and Liabilities to Other Depository Corporations (reserve deposits).

The annual growth rate of monetary base accelerated from 18.2 per cent in November 2013 to 18.5 per cent in December 2013.

On the sources side of the monetary base, net foreign assets of the Bank of Mauritius went up by Rs4,237 million or 4.3 per cent, from Rs99,261 million at end-November 2013 to Rs103,498 million at end-December 2013. Net Claims on Central Government went up by Rs2,620 million, from negative Rs13,552 million at end-November 2013 to negative Rs10,933 million at end-December 2013, mainly as a result of a decrease in liabilities to Central Government. Claims on Other Depository Corporations went up by Rs88 million, from Rs2,628 million at end-November 2013 to Rs2,716 million at end-December 2013, as compared to a rise of Rs161 million in the previous month.
