

Central Bank Survey: February 2014

The monetary base went up by Rs5,423 million or 9.2 per cent, from Rs58,669 million at end-January 2014 to Rs64,092 million at end-February 2014 as against a decrease of 5.9 per cent registered between end-December 2013 and end-January 2014. The growth in monetary base reflected mainly increase in Liabilities to Other Depository Corporations (reserve deposits).

The annual growth rate of monetary base accelerated from 17.1 per cent in January 2014 to 22.4 per cent in February 2014.

On the sources side of the monetary base, net foreign assets of the Bank of Mauritius grew by Rs5,623 million or 5.5 per cent, from Rs102,921 million at end-January 2014 to Rs108,544 million at end-February 2014. Net Claims on Central Government went up by Rs734 million, from negative Rs13,198 million at end-January 2014 to negative Rs12,464 million at end-February 2014, mainly as a result of a decrease in liabilities to Central Government. Claims on Other Depository Corporations went down by Rs46 million, from Rs3,506 million at end-January 2014 to Rs3,459 million at end-February 2014, as against a rise of Rs790 million in the previous month.
