

## Central Bank Survey: February 2009

The monetary base increased slightly by Rs82 million, or 0.3 per cent, from Rs31,526 million at the end of January 2009 to Rs31,608 million at the end of February 2009, as against an increase of 2.8 per cent recorded between end December 2008 and end January 2009.

The annual growth rate of monetary base stood at 22.4 per cent in February 2009, down from 23.9 per cent in January 2009.

On the sources side of the monetary base, net foreign assets of the Bank of Mauritius increased by Rs2,460 million, or 4.5 per cent, from Rs54,839 million at the end of January 2009 to Rs57,299 million at the end of February 2009. Net claims on budgetary central government decreased by Rs316 million, or 6.8 per cent from negative Rs4,644 million as at end January 2009 to negative Rs4,960 million as at end February 2009. Claims on other depository corporations decreased by Rs20 million or 2.6 per cent, from Rs798 million as at end January 2009 to Rs778 million as at end February 2009, as against a decrease of 21.2 per cent in the previous month.
