

## Central Bank Survey: February 2010

The monetary base rose by Rs1,890 million or 5.8 per cent, from Rs32,386 million at the end of January 2010 to Rs34,276 million at the end of February 2010, as against a fall of 9.9 per cent registered between end December 2009 and end January 2010. The expansion in monetary base during the month reflected solely the increase in reserve deposits.

The annual growth rate of monetary base accelerated to 9.0 per cent in February 2010, up from 3.3 per cent in January 2010.

On the sources side of the monetary base, net foreign assets of the Bank of Mauritius increased by Rs1,360 million or 2.2 per cent, from Rs62,412 million at the end of January 2010 to Rs63,772 million at the end of February 2010. Net claims on budgetary central government went up by Rs969 million or 8.1 per cent from negative Rs12,019 million at the end January 2010 to negative Rs11,050 million at the end February 2010. Claims on other depository corporations decreased by Rs17 million or 4.2 per cent, from Rs416 million at the end January 2010 to Rs399 million at the end February 2010, as against a drop of Rs1,011 million in the previous month.
