



Central Bank Survey: June 2013

The monetary base went up by Rs348 million or 0.7 per cent, from Rs52,746 million at end-May 2013 to Rs53,094 million at end-June 2013, as compared to a rise of 8.1 per cent registered between end-April 2013 and end-May 2013. The growth in monetary base reflected mainly an increase in liabilities to Other Depository Corporations (reserve deposits).

The annual growth rate of monetary base decelerated from 18.1 per cent in May 2013 to 15.6 per cent in June 2013.

On the sources side of the monetary base, net foreign assets of the Bank of Mauritius decreased by Rs492 million or 0.5 per cent, from Rs104,072 million at end-May 2013 to Rs103,580 million at end-June 2013. Net Claims on Central Government went down by Rs738 million, from negative Rs17,374 million at end-May 2013 to negative Rs18,112 million at end-June 2013, mainly as a result of an increase in liabilities to Central Government. Claims on Other Depository Corporations went up by Rs313 million, from Rs1,233 million at end-May 2013 to Rs1,546 million at end-June 2013, as against a decrease of Rs1,109 million in the previous month.
