

## Central Bank Survey: May 2011

The monetary base fell by Rs1,928 million or 4.4 per cent, from Rs43,613 million at end-April 2011 to Rs41,685 million at end-May 2011, as against a rise of 2.1 per cent registered between end-March 2011 and end-April 2011. The decrease in monetary base during the month reflected largely a drop in liabilities to Other Depository Corporations (reserve deposits).

The annual growth rate of monetary base stood at 18.7 per cent in May 2011, down from 28.0 per cent in April 2011.

On the sources side of the monetary base, net foreign assets of the Bank of Mauritius increased by Rs1,551 million or 2.2 per cent, from Rs71,682 million at end-April 2011 to Rs73,233 million at end-May 2011. Net Claims on Budgetary Central Government went down by Rs1,690 million or 46.8 per cent, from negative Rs3,610 million at end-April 2011 to negative Rs5,300 million at end-May 2011, reflecting mainly a rise in liabilities to Central Government. Claims on Other Depository Corporations went up by Rs364 million, from Rs265 million at end-April 2011 to Rs629 million at end-May 2011, as compared to an increase of Rs23 million in the previous month.
