

Monetary Developments: March 2014

Broad Money Liabilities (BML) grew by Rs2,711 million, from Rs369,067 million at the end of February 2014 to Rs371,778 million at the end of March 2014. The annual growth rate of BML went down from 7.0 per cent at the end of February 2014 to 6.8 per cent at the end of March 2014.

With regard to the counterparts of BML, domestic credit went up by Rs2,922 million, from Rs435,872 million at the end of February 2014 to Rs438,794 million at the end of March 2014. The annual rate of growth of domestic credit stood at 10.3 per cent at the end of March 2014, up from 9.1 per cent at the end of February 2014. Net claims on central government grew by Rs1,036 million or 3.0 per cent, from Rs34,818 million at the end of February 2014 to Rs35,854 million at the end of March 2014. Claims on other sectors went up by Rs1,886 million to Rs402,941 million at the end of March 2014 or by 0.5 per cent, as compared to an increase of 0.6 per cent recorded in the previous month. The annual growth rate of claims on other sectors expanded at a higher rate 9.0 per cent at the end of March 2014 compared to 7.8 per cent at the end of February 2014.

The net foreign assets of depository corporations decreased by Rs2,787 million or 0.7 per cent, from Rs374,464 million at the end of February 2014 to Rs371,677 million at the end of March 2014, as against an increase of 0.8 per cent in the previous month. Net foreign assets went down by 6.2 per cent in the year to March 2014, as against an increase of 0.7 per cent in the year to February 2014.
