



# *Inflation Expectations Survey* *(IES)*

***Survey Month: November 2011***

*(The reported survey findings represent the views of respondents and not necessarily those of the Bank of Mauritius.)*

## **Introduction**

The Bank of Mauritius carried out its 13<sup>th</sup> Inflation Expectations Survey in November 2011. Out of the 50 stakeholders chosen from the financial and real sectors of the economy, 47 responded to the survey. Consequently, the findings are based on these 47 responses.

## **Findings of the IES**

1. With respect to how respondents perceived the 6.4 per cent inflation rate for the twelve month ended October 2011, 49.0 per cent of respondents considered this rate as being high while 6.4 per cent judged it to be low. 25.5 per cent of respondents deemed this rate as being appropriate and 19.1 per cent viewed it as being too high.

2. With regard to their best description of the movement of prices over the preceding 12 months, 83.0 per cent of respondents indicated that prices of goods and services had gone up, while 8.5 per cent of respondents were of the opinion that prices had gone down. Another 8.5 per cent of respondents viewed that prices were unchanged.

3. Concerning the three main factors that accounted for the prevailing inflation pattern, *External Factors* were viewed by 83.0 per cent of respondents as accounting for the primary source of inflation in Mauritius. *Change in aggregate demand* was considered by 29.8 per cent of respondents as being the second most important factor. *Fiscal policy* was regarded by 27.7 per cent of respondents as the third most important factor.

4. In relation to movement of prices over the next 12 months, 72.3 per cent of respondents expected prices to go up, while 21.3 per cent of respondents anticipated a decrease in prices. 6.4 per cent of respondents expected that prices would remain unchanged.

5. Respondents were also requested to provide their expectations of the rate of inflation for the twelve month ending June 2012, a year ahead and December 2012.

- *June 2012*: 2.1 per cent of respondents were expecting inflation to be less than 4.5% and 59.6 per cent of respondents were expecting inflation to range from

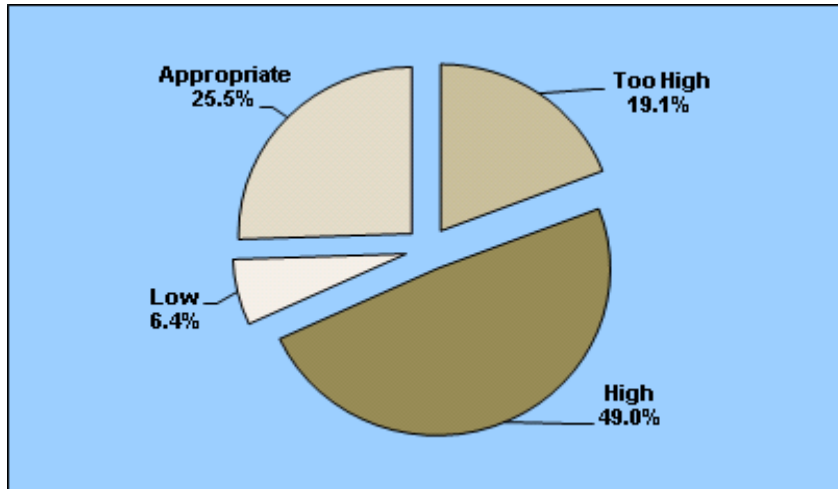
- 4.5% to 6.5%. 38.3 per cent of respondents were anticipating inflation to be above 6.5%.
- *A year ahead:* None of the respondents were expecting inflation to be less than 4.5% while 57.4 per cent of respondents were expecting inflation to range from 4.5% to 6.5%. 42.6 per cent of respondents were anticipating inflation to be above 6.5%.
  - *December 2012:* None of the respondents were expecting inflation to be lower than 4.5% while 57.4 per cent of respondents were expecting inflation to be within 4.5% and 6.5%. 42.6 per cent of respondents were anticipating inflation to be beyond 6.5%.

6. The mean inflation rates expected by respondents were 6.2%, 6.3% and 6.4% respectively, for the twelve months ending June 2012, a year ahead and December 2012.

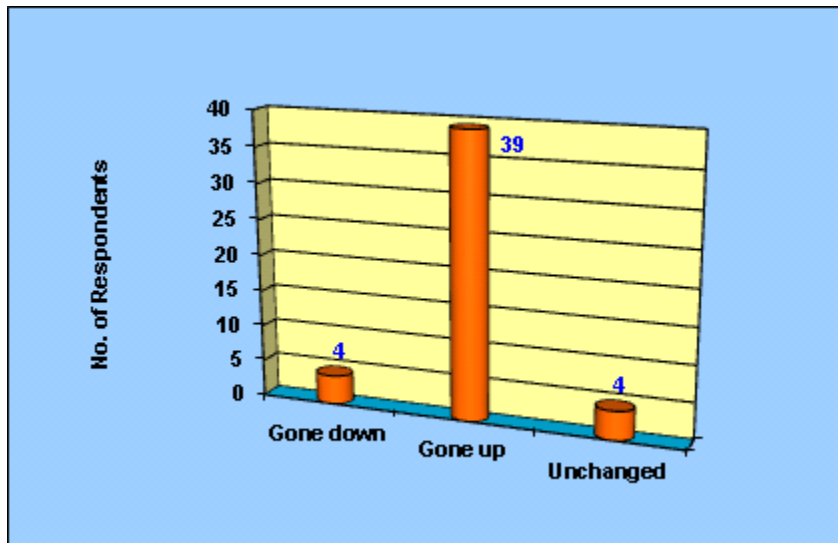

**Q1.2.** Which of the following best describes the movement of prices over the past 12 months?

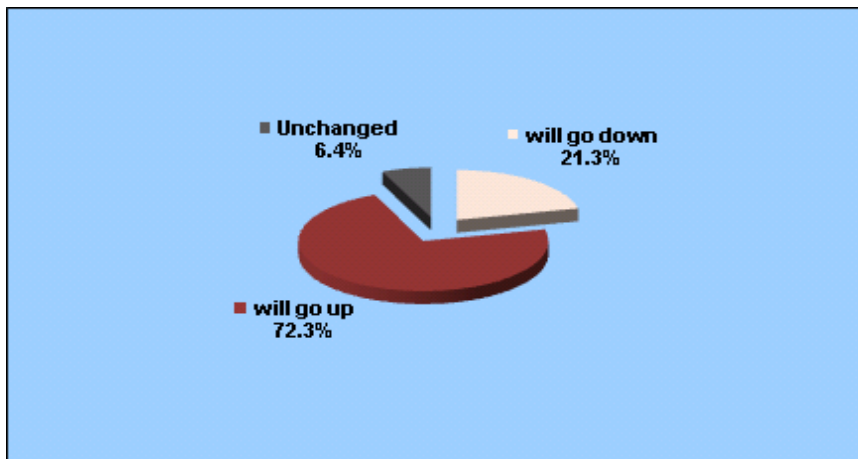
