ISSUE OF TREASURY NOTES

Pursuant to our Prospectus dated 13 September 2005, notice is hereby given that the Bank of Mauritius will, on **Wednesday 08 March 2006**, sell through auction on a yield basis, Treasury Notes, for a total nominal amount of **Rs1.2 billion**, with maturities of 2, 3 and 4 years bearing interest at the rate of 7.60, 7.90 and 8.25 per cent per annum respectively, under the terms and conditions specified in the Prospectus.
