## **TREASURY NOTES**

Pursuant to the Press Communiqué dated 01 August 2008, notice is hereby given that the Bank of Mauritius will, on **Wednesday 08 April 2009**, sell through auction on a yield basis, Treasury Notes, for a total nominal amount of **Rs1,200 million**, with maturities of 2, 3 and 4 years bearing interest at the rate of 6.25, 6.50 and 6.75 per cent per annum respectively. The other terms and conditions will remain the same as specified in our Prospectus dated 13 September 2005.

- Successful tenderers will be required to effect payment for their accepted bids by 11.00 a.m. on
  Friday 10 April 2009 at latest.
