## **Press Release**

**Leasing Facilities: End-December 2020** 

- 1. Fourteen companies provide leasing facilities to both households and corporates in Mauritius.
- 2. As at end-December 2020, total leasing facilities granted to the household and business sectors amounted to Rs22.2 billion. The motor vehicle segment accounted for 88.3 per cent of total outstanding leasing facilities, compared to 86.1 per cent a year earlier. As at end-December 2020, an amount of Rs19.6 billion was extended towards the purchase of motor vehicles, while the number of leases pertaining to the motor vehicle segment amounted to 36,039 (Table 1).
- 3. As at end-December 2020, motor vehicle leases granted to the business sector and household sector amounted to Rs9.9 billion and Rs9.7 billion, respectively.
