

## **TWENTY-YEAR GOVERNMENT OF MAURITIUS BONDS**

## 11 June 2025

Pursuant to the issuance plan dated 24 February 2025 and in accordance with section 5 of the Public Debt Management Act 2008 and section 57 of the Bank of Mauritius Act 2004, the Bank of Mauritius is pleased to announce the issue of a Twenty-Year Government of Mauritius Bonds maturing on **20 June 2045** through an auction to be held on **Wednesday 18 June 2025**, for a nominal amount of **Rs2,200 million** for settlement on **Friday 20 June 2025**.

- The Bank will receive bids from Primary Dealers for this auction on the same day, i.e. Wednesday 18 June 2025, on a yield basis quoted to two decimal places, in multiples of Rs100,000. Primary Dealers may submit, for their own account up to a maximum of five bids, one for each bid yield, which, however, should not exceed the tender amount in the aggregate.
- 2. Bids must be submitted **before 10.00 a.m. on Wednesday 18 June 2025**. Bids received after the prescribed time and date shall not be considered.
- 3. The results of the auction will be announced on the same day. Successful bidders will be required to effect payment of the cost price of the Bonds through the Mauritius Automated Clearing and Settlement System (MACSS) at latest by 11.00 a.m. on Friday 20 June 2025. Payment of maturity proceeds and interests accruing on the Bonds by the Bank will also be made through the MACSS.
- 4. The coupon rate for this auction will be set equal to or higher than the lowest accepted yield of the auction to be held on Wednesday 18 June 2025. Bidders whose accepted bids carry yields lower than the coupon rate will be required to pay a premium (over and above the face or nominal value). Successful bidders will in any case receive the yield that they specified in their bids.
- 5. The Bonds will be issued dated **20 June 2025** and will mature and be redeemed at par by the Bank of Mauritius on **20 June 2045**. The Bank may, at its discretion, allow the Bonds to be redeemed or converted into other instruments at market rates prior to maturity.
- 6. Interest on these Bonds will be paid half-yearly on 20 June and 20 December by the Bank during the currency of the Bonds to the bank account of the Primary Dealers. Interest will accrue on the Bonds as from 20 June 2025 on the nominal amount allotted and will cease on the date of their maturity.
- 7. The Bonds will be issued in Book-Entry form and records will be kept at the Bank of Mauritius. The Bonds may be freely traded and are transferable from one investor to another in multiples of Rs50,000.
- 8. In the event of oversubscription of the Bonds, the Bank may accept a higher amount than the amount put on tender.
- 9. The Bank of Mauritius reserves the right to accept or reject any bid either, in full or in part, without assigning any reason in respect thereof.
