

RE-OPENING OF 5.25% THREE-YEAR GOVERNMENT OF MAURITIUS TREASURY NOTES

25 July 2025

On 25 July 2025, the Bank of Mauritius issued a 5.25% Three-Year Government of Mauritius Treasury Notes maturing on 25 July 2028, for an amount of Rs3,000 million through an auction held on 23 July 2025.

- 1. In accordance with section 5 of the Public Debt Management Act 2008 and section 57 of the Bank of Mauritius Act 2004, the Bank is pleased to announce the re-opening of the 5.25% Three-Year Government of Mauritius Treasury Notes maturing on 25 July 2028, through an auction to be held on Friday 1 August 2025, for a nominal amount of Rs2,400 million for settlement on Monday 4 August 2025.
- 2. The Bank will receive bids from Primary Dealers for this auction on the same day, i.e. **Friday 1 August 2025** on a yield basis quoted to two decimal places, in multiples of Rs100,000. Primary Dealers may submit, for their own account up to a maximum of **five** bids, one for each bid yield, which, however, should not exceed the tender amount in the aggregate.
- 3. Bids must be submitted **before 10.00 a.m. on Friday 1 August 2025**. Bids received after the prescribed time and date shall not be considered.
- 4. The results of the auction will be announced on the same day and successful bidders will be required to effect payment of the cost price of the Treasury Notes through the Mauritius Automated Clearing and Settlement System (MACSS) at latest by 11.00 a.m. on Monday 4 August 2025. Payment of maturity proceeds and interest accruing on the Treasury Notes by the Bank will also be made through the MACSS.
- 5. The Treasury Notes will be issued dated 4 August 2025 and will mature and be redeemed at par by the Bank of Mauritius on 25 July 2028. The Bank may, at its discretion, allow the Treasury Notes to be redeemed or converted into other instruments at market rates prior to maturity.
- 6. Interest on these Treasury Notes will be paid half-yearly on 25 January and 25 July by the Bank during the currency of the Treasury Notes to the bank account of the Primary Dealers. Interest will accrue on the Treasury Notes as from 25 July 2025 on the nominal amount allotted and will cease on the date of their maturity.
- 7. The cost price for the Treasury Notes allotted will include interest from 25 July 2025 to 3 August 2025.
- 8. The Treasury Notes will be issued in Book-Entry form and records will be kept at the Bank of Mauritius. The Treasury Notes may be freely traded and are transferable from one investor to another in multiples of Rs50,000.
- 9. In the event of oversubscription of the Treasury Notes, the Bank may accept a higher amount than the amount put on tender.
- 10. The Bank of Mauritius reserves the right to accept or reject any bid either in full or in part, without assigning any reason in respect thereof.
